**2025 BUDGET ADOPTION**

President Rutledge presented Ordinance 2024-10-22-02 Establishing a Capital Project Fund – 4450 Community Growth and Innovation Fund for the funds from the Subrecipient Agreement. Mr. Rutledge called for a motion to suspend the approval of the rules of ordinances, which typically require two public readings. Mr. Randy Rankin motioned to suspend the rules and the second reading requirement. Mr. Mike Baehl seconded the motion.

President Rutledge asked for a motion to accept Ordinance 2024-10-22-02 Establishing a Capital Project Fund – 4450 Community Growth and Innovation Fund. Mr. Baehl made a motion to accept Ordinance 2024-10-22-02 as presented. Mr. Randy Rankin seconded the motion.


